Please note the following rules and changes made from last year. You must check in with Bruce. We will then take you to your space.

1. All spaces prepaid by **July 1, 2024** will be reserved. Please send payment with registration and tax forms to Bruce at the address below. Remaining spaces after the deadline will be given out at a first-come first-serve basis. Cost of spaces is \$25.00 for 15'X15', \$30 for 20'X15', \$40 for 30'X15' space and so on. This cost is for Saturday and Sunday. Hoedown does not charge for Friday, since we consider it a set-up day. **NO PERSONAL CHECKS.**
2. You must stay within your designated area with your merchandise and camping equipment. No one is allowed to drive into the park until you have registered with Bruce. The park is often crowded throughout the weekend and safety is a concern. Anyone arriving after 2PM on Saturday will be subject to putting his or her booth up on the street. There will be no parking on Spruce Street on the south side of the park during the parade on Sunday as this is a parade route.
3. Vehicles will not be allowed to enter or leave the park once you are set up. We require you to park on the street only. No vehicles will be allowed in the park after 10AM on Saturday. No vehicles may be left in the park. You may bring an umbrella or awning, as there may be shade only part of each day. The picnic tables are for public use and not intended for vendor use.
4. No electricity is available. The use of generators is allowed. Plugging into any electrical outlets throughout the park is prohibited and you will be unplugged. Only one verbal warning will be given, after that you will be asked to leave.
5. **DRUGS OR DRUG PARAPHENALIA, including fake cigarettes, and such as jewelry, clothing, lighters, etc. are not allowed. Also, no smoke or stink bombs, any type of bombs period, firecrackers, or paintball accessories.** Only one verbal warning will be given, after that you will be asked to leave. You will be responsible for park clean up of these items if you are caught selling and asked to leave.
6. **You must pay for your spot in advance to ensure you will have your reserved spot. As noted above we will not accept personal checks, cash and or money orders, cashiers checks are only expectable. Money's cashed and or collected will not be refunded after July 1st. Do not mail your paperwork in without money and expect your exact spot.**
7. **Also if you are bringing PETS. You are responsible for them any and all ways. Please make sure that you care cleaning up after them as well. Please make sure they are not a hazard to others. It is NOT HOEDOWNS LIABILITY IF THEY BITE someone.**

The Department of Revenue states that **all** vendors are required to have a valid MN Tax Identification Number. If you do not have one you need to call 651-296-6181 and they will issue a number over the telephone. You must have this number on your registration form. You must be over 18 to sell items or have parent permission.
